



FIELD NOTES for a 10.01 acre tract of land out of Labor 17, League 606, State Capital Lands, Lamb County, Texas.

BEGINNING at a 1/2" iron rod set with a cap inscribed "RPLS 4263" (hereinafter referred to as an OJD cap) in the north right-of-way line of F.W. Highway 54 which bears S. 87° 21' 10" E. a distance of 1214.82 feet and N. 02° 38' 50" E. a distance of 50.00 feet from a mag nail set at the southwest corner of said Labor 17 for the southwest corner of this tract.

THENCE N. 02° 27' 05" E. a distance of 1143.11 feet to an OJD cap set for the northwest corner of this tract.

THENCE S. 87° 21' 10" E. a distance of 302.15 feet to an OJD cap set for the northeast corner of this tract.

THENCE S. 02° 27' 05" W. a distance of 1143.11 feet to an OJD cap set in said north right-of-way line of said F.W. Highway 54 for the southeast corner of this tract.

THENCE N. 87° 21' 10" W., along said right-of-way line, a distance of 302.15 feet to the POINT OF BEGINNING and containing 10.01 acres of land.
