

### Tract 3

FIELD NOTES for a 10.01 acres tract of land out of Labor 17, League 666, State Capitol Lands, Lamb County, Texas.

THENCE S. 87° 22' 46" E., at 25.0 feet pass an OJD cap set in the east margin of said county road, a total distance of 1424.15 feet to an OJD cap set for the northeast corner of this tract.

THENCE S. 02° 39' 55" W. a distance of 306.18 feet to an OJD cap set for the southeast corner of this tract.

THENCE N. 87° 22' 46" W., at 1399.15 feet pass an OJD cap set in said east margin of said county road, a total distance of 1424.15 feet to said west line in said county road for the southwest corner of this tract.
